Delhi Cong accuses AAP govt of compromising national security

■ **Delhi government compromised the security of the nation for kickbacks in the installation of CCTV cameras in Delhi by awarding the contract to a Chinese firm, alleged Maken**

The Delhi unit of the Congress party has accused the Delhi government of compromising the security of the nation for kickbacks in the installation of CCTV cameras in Delhi by awarding the contract to Chinese Government PSU, Hikvision.

It is an "open and shut case of corruption and compromise of the national security, alleged Ajay Maken, president, Delhi Congress party. The contract for the CCTV camera project was not given to BEL till Hikvision was included in BEL's vendors' list, Maken further said, while talking to reporters here on Friday.

He also sought resignation of Delhi Chief Minister Arvind Kejriwal, saying if Kejriwal does not resign, Delhi Congress will hold a demonstration outside the official residence of Kejriwal on Sunday, 13 May. An enquiry against the



Defence Ministry will also be sought as to how the Indian PSU BEL, which comes under the Defence Ministry, included Chinese Government PSU Hikvision as its

vendor company, Maken asked.

The Aam Aadmi Party Government in Delhi has compromised the security of the nation for kickbacks in

the installation of CCTV cameras in Delhi by awarding the contract to Chinese Government PSU Hikvision, having 58 per cent share of the Chinese Government,

through BEL (Bharat Electronics Ltd) by making it a vendor of BEL, Maken alleged.

Maken said whenever there is a tussle between the

Delhi and Central governments, the Lt. Governor of Delhi bailed out the AAP government though on the surface, it is made out a clash between the AAP government and the LG.

Congress president Rahul Gandhi had said yesterday that the Chinese troops had participated in the parade of the Pakistan army. He said in such a time, it will be a huge national security risk if the contract for the installation of the CCTV cameras in Delhi is given to Chinese PSU Hikvision, Maken further said.

Others who were present in this press conference were Delhi in-charge P.C. Chacko and former Delhi Ministers Dr A.K. Walia, Arvinder Singh Lovely and Haroon Yusuf, chief spokesperson, Delhi Congress Sharmistha Mukherjee, Kuljit Singh Nagra, secretary AICC and Punjab MLA, former Delhi Minister Rajkumar Chauhan and senior leader Chattar Singh.

Proposal to procure 1,000 standard-floor buses fails to get Delhi cabinet nod

The transport department's proposal to procure 1,000 new standard-floor buses to be run under the cluster scheme failed to get the Delhi cabinet's approval today but is expected to be finalised next week. The cabinet raised queries over the proposal and sought details about the "viability gap" formula from the department, Delhi government minister Gopal Rai said.

"The proposal was discussed in detail. The cabinet has made 2-3 queries and sought a report on viability gap formula from the transport department. A final decision on it will be made by the cabinet in its next meeting on Tuesday," Rai said.

The deadline for the cabinet nod to procure 1,000 each electric and CNG buses was set as April 30, according to Deputy Chief Minister Manish Sisodia budget speech on March 22. The proposal for procurement of the buses was delayed and was not on the agenda of the cabinet meeting held on Thursday. It was expected to get cabinet approval on Friday, officials had said.



The other proposal for 1,000 "e-buses" will come up before the cabinet later as it is being firmed up by the departments concerned, they had said. Under the cluster scheme, 1,648 buses are being run by the Delhi Integrated Multi Modal Transit System (DIMTS). Another 3,900 low-floor buses are run by the Delhi Transport Corporation (DTC). According to independent sources, Delhi requires 10,000 to 15,000 buses to meet its transport needs.

Russian dies in Delhi

A 44-year-old Russian national died after falling unconscious at the FRRO office while his deportation formalities were going on, police said on Friday.

Sergey Erin died on Wednesday afternoon at AIIMS, they said.

Erin was detained in the early hours of Wednesday after the police were informed that a man was acting violently and pelting stones at passersby near Inderlok in north Delhi.

Some locals had tried to control him but Erin was banging his head on the road and hitting himself. He also resisted accompanying the police personnel when he was asked to do so, they said. At 3 am, he was taken to the Sarai Rohilla police station and then to the Bara Hindu Rao hospital for a medical exam where the doctors said he had minor abrasions, police added.

In the morning, the police personnel took him to the FRRO office in RK Puram for completing his deportation formalities.

During lunch time, he fell

unconscious and was rushed to All India Institute of Medical Sciences (AIIMS) where efforts were made to resuscitate him. The doctors later declared him dead, they added.

Police said he was suspected to have suffered a cardiac arrest but a post-mortem report would confirm the exact reason of his death.

The police launched an investigation into Erin's death and it was probing whether he was attacked by locals on the night of his violent outburst.

PWD scam: Court issues production warrant for Kejriwal's arrested kin

A Delhi court on Friday issued production warrant for Chief Minister Arvind Kejriwal's relative Vinay Bansal, arrested in connection with an alleged scam in the Public Works Department (PWD), after the Tihar jail authorities failed to produce him.

The court took a stern view and directed the jail authorities to explain the absence of Bansal, a nephew of Kejriwal, who was sent to one-day judicial remand yesterday after he fainted in the court room and was rushed to nearby hospital.

"The accused has not been produced by jail superintendent, Tihar jail. No intimation from the superintendent regarding his non-production. Production warrant be issued against the accused with a direction to the jail superintendent to explain non-production of the accused. The accused to be brought tomorrow," Additional Sessions Judge Sanjay Khanagwal said.

Bansal, through his counsel B S Joon, also moved a



bail application on the ground that all allegations were baseless and the FIR filed against him was false and frivolous. He said Bansal was currently in Lok Nayak Jai Prakash Narayan Hospital here.

The application, which will be heard on May 14, also said he has been cooperating with the investigating agency since the FIR was lodged in May last year and never

evaded the process of law.

A duty magistrate had yesterday remanded Bansal to a day's judicial custody while refusing the Anti-Corruption Branch's plea seeking his three-day remand.

In the court room packed with lawyers and mediapersons, Bansal had fainted during the hearing and a stretcher was brought to take him to the CAT ambulance stationed outside the court

premises. The proceedings were halted for a few minutes.

The probe agency had yesterday argued that custodial interrogation was necessary for digging out the true factual position in the case.

Bansal, the son of Kejriwal's late brother-in-law Surender Bansal, was arrested yesterday by the ACB. Three FIRs, including one against a company run by the

chief minister's brother-in-law Surender Bansal, were registered by the ACB in this case on May 9 last year.

Three companies, including Renu Constructions (owned by Bansal, Kamal Singh and Pawan Kumar), were also named in the FIRs.

In a complaint, Rahul Sharma, founder of NGO Roads Anti-Corruption Organisation (RACO), had alleged financial irregularities in building a drain in north-west Delhi and that Kejriwal and PWD minister Satyendra Jain misused their office for grant of contracts to Bansal. However, they were not named in the FIR.

Delhi records season's hottest day at 42.8 deg C

The national capital on Friday recorded the season's hottest day, with the maximum temperature settling at 42.8 degrees Celsius, three notches above the season's average.

The minimum temperature was recorded at 24.2 degrees Celsius, a notch below the normal, said a Meteorological (MeT) department official.



The Safdarjung observatory, recording of which is considered the official figure for the city, registered a maximum temperature of 42.8 degrees Celsius, while areas under Palam, Lodhi Road, Aaynagar and Ridge recorded 42.9, 41, 43.2 and 42.4 degrees Celsius respectively, the official said.

The humidity oscillated between 74 and 18 per cent. The Met office has forecast overcast skies and dust storm accompanied by squall towards the night tomorrow.

"The maximum and minimum temperatures are expected to hover at 43 and 26 degrees Celsius respectively," the weatherman said. PTI

CCTV project: Delhi Home Secretary holds meeting, defies govt stand

Defying the AAP government's stand, Delhi Home Secretary Manoj Parida today chaired a meeting of the Lieutenant Governor-appointed committee on a project for installation of CCTV cameras, in what could trigger another confrontation with the AAP dispensation and the L-G's office.

An official said Parida would call another meeting of the six-member committee in the next five-six days and discuss various aspects such as common framework for installation, monitoring and other issues related to CCTV cameras in public spaces.

The Arvind Kejriwal government has declared as "null and void" the Parida-headed panel constituted by Lt Governor Anil Bajjal, saying that it was the responsibility of the government to install CCTV cam-



eras aimed at ensuring women's safety in the city.

In a letter to Bajjal on Thursday, Delhi Home Minister Satyendar Jain directed Parida not to proceed with the committee. The Home Secretary received the communication from the minister's office this evening.

The official said that following the direction of L-G who is the "head of government", Parida today held a meeting of committee and discussed common framework for installation, monitoring and other issues re-
