नई दिल्ली। रामजन्म भूमि बाबरी मस्जिद विवाद में एक नया मोड आया है। शिया वक्फ बोर्ड ने उच्चतम न्यायालय में शपथ पत्र दाखिल करके कहा है कि विवादित जमीन पर राम मंदिर का निर्माण होना चाहिए जबकि मस्जिद उससे कुछ दूर मुस्लिम इलाके में बनाई जानी चाहिए। इस विवादित मामले में शिया वक्फ बोर्ड ने दाखिल शपथ पत्र में यह भी दावा किया है कि बाबरी मस्जिद शिया वक्फ की थी। इसे देखते हुए इस मामले में दूसरे पक्षकारों के साथ वार्ता लाभ और सौहार्दपूर्ण समाधान तक पहुंचने का अधिकार केवल उसी के पास है। बोर्ड का कहना है कि यदि मंदिर-मस्जिद मसले का समाधान हो जाए और निर्माण हो गया तो
