# Delhi's air quality remains 'severe' **Over 400 heavy vehicles stopped** from entering city

#### New Delhi/November 10

Delhi's air quality remained in the 'severe' category on Friday despite a slow but "significant' improvement in pollution levels with the AAP government restricting the entry of heavy and medium goods vehicles into the national capital as an emergency measure.

Government-run agency SAFAR said that the city's air quality would remain in the severe category till Saturday, as the already toxic situation caused by smoke from fireworks is likely to aggravate further due to intensified stubble burning in neighbouring states. Despite severe pollution, stray incidents of firecracker burning were reported from various localities in the national capital on Thursday night.

Delhi's air quality on Thursday went off the charts to the "severe plus emergency" category. The city recorded the

overall air quality index (AQI)

of 642, according to System of Air Quality and Weather

Forecasting And Research (SAFAR).

It said the city's air quality has "improved significantly" since Thursday, but the recovery was slow due to low surface wind speed. The AQI was recorded in the severe category at 453 on Friday, according to data from the Central Pollution Control Board (CPCB).

Twenty-six areas in Delhi recorded 'severe' air quality, while seven areas registered very poor' air quality, according to CPCB data. On Friday, the PM2.5 (particles in the air with a diameter of less than 2.5 micrometres) level was recorded at 303 µgm-3, five times the permissable limits.

The PM10 (particles in the air with a diameter of less than 10 micrometres) level was recorded at 440 µgm-3, four times the

# NRI falls to death from Taj Mansingh terrace garden in Delhi New Delhi/November 10

A 48-year-old non-resident Indian (NRI), settled in the United States with his family, died after 'mysteriously' falling from the second floor terrace garden of Taj Mansingh Hotel in Lutyens' Delhi on Wednesday. The incident took place almost 10 hours after he checked into the hotel after flying into the city from the United States, police said.

Police suspect the man, identified as Mangalam Narendra, was drunk and was looking for a place to urinate when he went to the terrace garden and 'accidentally' fell from one of the corners on the back of the lawn around noon. The hotel staff spotted him in an injured condition around 11.30 pm — almost 12 hours after the incident. Ruling out the possibility of foul play, police said CCTV camera footage shows that the man was alone on the terrace garden when the incident took place. His earphones were found on the overhang below the terrace garden. Police suspect Narendra was trying to stop his earphones from slipping off his hands when he lost his balance and fell to his death.



There has been an unfortunate incident and we extend our deep condolences to the family. We are cooperating with the authorities and extending our full support," read a statement issued by a spokesperson on behalf of the Indian Hotels Company Limited (IHCL).

Deputy commissioner of police (New Delhi) Madhur Verma said Narendra fell at the back of the hotel building, close to the swimming pool. An electrician at the hotel was going to check the electric channel when he spotted the guest lying injured and unconscious on the ground. The electrician told the hotel's security staff, who, in turn, informed police about the incident. The injured man was rushed to a nearby

hospital, where he was declared brought dead, said the DCP.

"There is no eyewitness to the incident. We scanned the footage several cameras but except Narendra nobody is seen entering the terrace garden half an hour before or after the incident. No case has been registered. An inquest proceeding under section 174 of CrPC has been initiated,' said DCP Verma.

A police officer said Narendra had checked into the hotel around 2 am on Wednesday, even though he had booked a room from Tuesday. He was staying in room number 528 on the fifth floor. The CCTV footage of the floor shows him locking the door of his room and walking in the corridor.

The footage shows Narendra taking the staircase to come down. He reached the second floor where the staircase ended. His moved hinted that he was urgently looking for a bathroom to urinate. Narendra then tried using the lift, but since it was busy he did not wait for it. He is then seen going towards the terrace garden," said the officer. Police said a visiting card found in Narendra's bag suggested that he worked.



#### New Delhi/November 10

A three-year-old died after falling into an open 'tank' of an under-construction building near his home in outer Delhi's Sanjay Colony, close to Narela, on Friday morning. The boy was playing with other children when he went inside the building to hide and accidentally fell into the open 'tank' around 11am. According to police, nobody saw him falling. Though locals said that it was a septic tank in which the boy fell, the police said that the child fell into an uncovered manhole. Locals told the police that the building's construction had been halted around six months ago and the tank had been uncovered since then. Additional deputy commissioner of police (Rohini) Gaurav Sharma said a case of death by negligence under Section 304A of the Indian Penal Code was registered against the building owner. "Prima facie, the cause of death is drowning. But we are waiting for the child's autopsy report to ascertain the exact cause of death," Sharma said. The boy lived with his parents, who are daily wagers, his sister and his grandfather in a rented house in Sanjay Colony, Narela. The family is from Bihar. The child's father, Shankar Bhagat, had gone to work when the incident took place. The boy's mother Nutan Devi told the police that she gave her son a bath and started cooking lunch when he went out to play. His grandfather, Hari Prakash, was resting on a mat outside the house. Nutan later went looking for her son but couldn't find him. She asked her father-in-law and he told her that he had seen him playing with some children. "When we could not find him, we panicked and alerted our neighbours. They looked for him in the neighbourhood and then went inside the under-construction building. The septic tank was uncovered. The neighbours looked into the tank using.

#### New Delhi/November 10

The Delhi government's Public Works Department (PWD) will early next year start repair work on four of the city's busiest flyovers - three in south Delhi and one in North Delhi - that were constructed for the 1982 Asian Games or in the early 1990s after an initial study found they had developed cracks and needed immediate work.

The four are the Lodhi Road flyover on Lala Lajpat Rai Road, the Oberoi flyover on Zakir Hussain Marg, the Chirag Dilli flyover on Outer Ring Road, and the ISBT Kashmere Gate flyover. PWD officials say these flyovers will be repaired on a priority basis because traffic volume is high on the arterial roads they connect.

ISBT Kashmere Gate and Chirag Dilli flyovers witness about 250,000-300,000 vehicles a day. traffic police data reveals. About 150,000-200,000 vehicles use Lodhi Road and Oberoi flyovers daily. The Lodhi Road and Oberoi

flyovers were constructed for the Asian Games held in Delhi in 1982, while the ones at ISBT Kashmere Gate and Chirag Dilli were constructed in 1991 and 1992 respectively.

Earlier this year, the department hired Council of Scientific and Industrial **Research-Central Road Research** Institute (CSIR-CRRI) to inspect the condition of eight flyovers in Delhi, which were constructed in the 1980s and 1990s. "We identified these four flyovers based on the visual inspection report submitted by CSIR-CRRI.

These flyovers are very old and need immediate repair. We have appointed consultants to do a detailed study on the condition of the four flyovers," said a senior PWD official familiar with the plan who asked not to be identified. "The consultant will examine

the quality of concrete, check for rusting in reinforcement material (iron bars in the base), strength of the structure, width of cracks etc. The expansion joints will have to be replaced," said the official.

CSIR-CRRI's bridge and structures division carried out the visual inspection of these flyovers and submitted its report in June 2018. "In our report, we pointed out that these flyovers, which are very old, have developed cracks and recommended that PWD get non-destructive testing and a detailed study done on the condition of these flyovers and accordingly plan for their rehabilitation," said GK Sahoo, head of bridges and structures at CSIR-CRRI. PWD officials say that the consultants will first.

# AP files police complaint against Manoj Tiwari for inciting violence at signature bridge

#### New Delhi/November 10

The Aam Aadmi Party (AAP) filed a written police complaint against Delhi BJP chief Manoj Tiwari on Friday, alleging that he incited violence at the inauguration of Signature Bridge on November 4. AAP leaders said that they decided to complain after the police failed to file an

FIR against Tiwari. A delegation led by Rajya Sabha MP Narain Dass Gupta sought an FIR against Tiwari, MP from north east Delhi, during their meeting with Delhi police commissioner Amulya Patnaik. Gupta alleged that Tiwari, who was accompanied by his party workers, posed a threat to Delhi chief minister Arvind Kejriwal and deputy chief minister Manish Sisodia at the inauguration.

Sabha colleague, Sushil Gupta. The CM, deputy CM, ministers and senior officers of Delhi government were also present. No FIR has been registered even after four days, despite the fact that the premeditated criminal action of BJP leader Manoj Tiwari and his supporters had put the lives of the CM, the deputy CM and other ministers at risk," Gupta, as an "eyewitness", stated in the police complaint.

Minutes before the "I was seated on the inauguration of the bridge,

Tiwari and his workers were allegedly involved in a scuffle with AAP workers and the police. While Tiwari, who was not invited to the event, said he wanted to be present as it was being held in his constituency, the AAP alleged he and his workers had come to attack the CM and other leaders present there.

"In my view, the police was duty-bound to register an FIR against Manoj Tiwari and his hoodlums who committed this serious cognizable offence against police officers on duty. nfortunately, this has not happened," the complaint read. The AAP's complaint comes days after the police booked several persons, including AAP lawmaker Amanatullah Khan, for allegedly threatening Tiwari. Khan, an MLA from Okhla, was seen pushing Tiwari.
