India-New Zealand Test Series : Superb Sundar

PUNE (AGENCY)

All-rounder Washington Sundar justified his selection with a career-best 7/59 to help India bowl out New Zealand for 259, but the hosts lost skipper Rohit Sharma early in their first innings when stumps were drawn on day of the second Test, here on Thursday. India crawled to 16 for one in 11 overs with Yashasvi Jaiswal (6 not out) and Shubman Gill (10 not out) at the crease, trailing by another 243 runs in the first innings. Tim Southee cleaned up Rohit for a nine-ball duck, forcing the hosts to be extra cautious with the debacle of first innings in the Bengaluru Test still



fresh in the mind. Rohit, who was cleaned up for the third time in the series and for the second time by Southee, was squared up as he looked to defend in the line of the delivery but the ball moved away to beat his outside edge and crash into the off-stump. Southee thus

became the first among fast bowlers to take a wicket in this Test after a dominating show by the Indian spin duo of Sundar and R Ashwin (3/64), who did not allow New Zealand to break free. The 25-year-old Sundar, playing his first Test for India since March, 2021,

ran through New Zealand after Ashwin claimed the first three wickets in the innings to move past his Australian peer Nathan Lyon in the list of highest wicket-takers in Tests. Ashwin began by trapping New Zealand captain Tom Latham (15) in front of the wickets and getting Will Young (18) caught behind in the first session, while Sundar took the centrestage towards the end of the second. While he was mealy to begin with as New Zealand batters looked to consolidate, Sundar reaped rich dividends for his perseverance. He swung the momentum in India's favour with two late wickets in the second session,

including the in-form Rachin Ravindra, as New Zealand stumbled to 201/5 at tea. Ravindra's dismissal close to the tea break proved instrumental as New Zealand could never recover from the blow and folded in the final session without much resistance. The young batter looked primed for another big knock but Sundar's brilliance stopped him in his tracks. Of his seven dismissals in an outstanding spell on a day one wicket, Sundar showed mastery in hitting the off-stump to snare five of his victims bowled, one pinned in front of the wickets while the other caught by fellow tweaker Ashwin.

NorthEast United FC hope to halt Jamshedpur FC's winning streak

GUWAHATI (AGENCY)

Jamshedpur FC will look to continue their winning streak when they face a doughty NorthEast United FC in an away Indian Super League (ISL) match here on Saturday. The Jamshedpur side is placed second on the table, having accumulated 12 points from five games, and the hosts have managed only five points from as many contests and are positioned 10th. But beyond those contrasting numbers, the Highlanders have remained unbeaten in their previous two fixtures against the Red Miners. Meanwhile, scoring a goal in this match will mark NEUFC's joint-longest goal-scoring streak against JFC, having done so earlier between January 2021 and February 2022. But JFC have also been taking risks

up front, as indicated by their passing accuracy of 57.1% in the opposition's half this season. The number also proves that they have been creating chances



in the final third, allowing them to score 10 goals until now. Their possession rate of 36.2% is the lowest in this ISL, but it allows them to play fearless football by letting the opposition dominate with the ball before launching their counter-attack. NorthEast head coach Juan Pedro Benali played down the talk that his team is under pressure

after managing just one win in their last five games. However, he stressed on the need to improve their defence. "There is no pressure on us. But we are hungry. I don't look at points, but I look at the goals scored against us. Two goals against us per game is too much," Benali said on the eve of the clash. "We need to decrease that and if we do so, then we will automatically do well as we are one of the teams to have scored the most goals this season."

On the other hand, Jamshedpur head coach Khalid Jamil said his team is desperate to finish on a high. "Everyone is doing well. All the focus is on tomorrow. We have a vital game coming up," Jamil noted. "NorthEast United FC have a very good coach and a good mix of Indian and foreign players."

New Zealand swell their lead to 188 at tea after Santner's sensational bowling

PUNE (AGENCY) Opener Tom Latham and Will Young batted with confidence in the second innings as New Zealand consolidated their position in the second Test reaching 85/2 at tea to take an overall lead of 188 runs against India on day two here on Friday. Latham (37 not out) and Young (23) overcame the early hiccup of losing Devon Conway by stitching together a 42-run partnership after Kivi spinner Mitchell Santner had demolished the Indian batting line-up for 156 in the first innings with career-best figures of 7/53 in 19.3 overs. India started the day on a positive note with Shubman Gill (30) and Yashasvi Jaiswal (30) adding 49 for the second wicket before six wickets fell for the addition of 53 runs as the hosts were left tottering at 107 for 7 at lunch. Virat Kohli played the most forgettable shot of the morning to be clean bowled for 1. Santner then returned in the post-lunch session to dismiss Ravindra Jadeja and Akash Deep and Jasprit Bumrah cheaply. Brief scores: New Zealand - 1st Innings 259 and 85 for 2 in 20 overs (Tom Latham 37 batting, Will Young 23). India - 1st Innings 107 for 7 in 38 overs (Shubman Gill 30, Yashasvi Jaiswal 30, Mitchell Santner 7/53, Glenn Phillips 2/26).

Loss in 2018-19 series more hurtful than 2020-21 defeat to India: Pat Cummins

SYDNEY (AGENCY) Australia skipper Pat Cummins believes that the 2018-19 Test series loss to India was more hurtful than the 2020-21 debacle under his captaincy as the home team was simply outplayed in that engagement. India, under Virat Kohli, defeated Australia 2-1 in the 2018-19 rubber with the skipper and Cheteshwar Pujara playing a pivotal role in the historic triumph against the Tim Paine-led side. During the 2020-21 series, a hugely-depleted Indian side again bagged the series 2-1, defeating the hosts at their stronghold Gabba for the first time in a Test match in 32 years. "I actually thought the series before (2018-19) was worse because we got completely beaten whereas that series (in 2020-21) was quite (keenly) fought. I thought they (India) played like fantastically well to win at the Gabba," Cummins told.

Indian hockey team beats world champions Germany 5-3 in 2nd Test

NEW DELHI (AGENCY)

Skipper Harmanpreet Singh and Sukhjeet Singh scored a brace each to hand India a 5-3 win over world champions Germany in the second hockey Test but the hosts lost the two-match series via shoot-out at the Major Dhyan Chand Stadium here on Thursday. Elian Mazkour (7th, 57th minutes) scored twice for Germany, who took the early lead, while Henrik Mertgens (60th) was the other goal getter for the visitors. But India turned the table in the second half, with goals from Sukhjeet Singh (34th and 48th), skipper Harmanpreet Singh (42nd and 43rd) and Abhishek



(45th) to level the two-match series. In the shoot-out, which India lost 1-3, Harmanpreet, Abhishek and Mohammed Raheel missed while Aditya was the lone scorer. India custodian Krishan Bahadur Pathak made two fine saves, but couldn't save his side from losing in the shoot-out. The

Indians started on the front foot and created early chances but failed to breach the German defence.

It was Germany who took the lead in the seventh minute through Elian Mazkour, who scored with a fierce reverse shot from the right corner. Two minutes later, debutant Aditya Arjun

Lalage came close to scoring his first goal for India but his shot from a Jarmanpreet Singh pass was saved by German goalkeeper Joshua Nnaji Onyekwue. India kept up the pressure and secured their first penalty corner in the next minute but the variation didn't work out well. The Indians secured another penalty corner in the next minute but Manpreet Singh couldn't stop the push. The Germans secured a penalty corner in the 12th minute but Lukas Windfeder shot wide. Minutes later, it was India's turn to earn a penalty corner and the hosts went for a beautiful variation with Amit Rohidas laying.

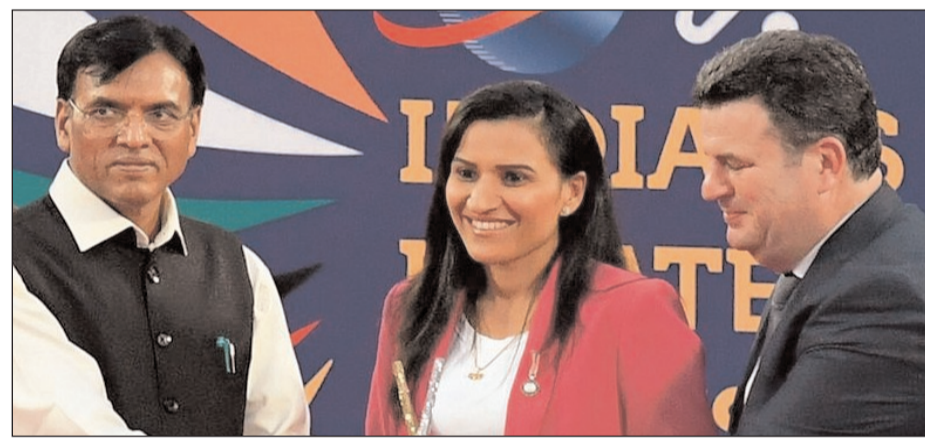
Rani hangs boots, wishes Olympic podium finish for women's team

Minister of Youth Affairs and Sports Mansukh Mandavjiya presents a trophy to former hockey team captain Rani Rampal Manas Ranjan Former Indian women's hockey team captain Rani Rampal announced her retirement on Thursday, ending a glittering 16-year career during which she became an inspiration for beating abject poverty and conservative views at a small town in Haryana where her father worked as a cart-puller. The 29-year-old will sign off as one of India's

most decorated hockey players after leading the women's team to its best-ever finish at the Olympics - a fourth place at the Tokyo Games in 2021. "It's been an outstanding journey. I never thought I will play for so long for India.

I have seen a lot of poverty from childhood but focus was always to do something, represent the country," she told reporters here. She was honoured with the Major Dhyan Chand Khel Ratna Award in 2020 and was also a recipient of the Padma Shri, the country's fourth highest civilian award, in the same year. She was recently



roped in as the national coach for sub-junior women players. Rani has also joined Soorma Hockey

Club, representing Haryana and Punjab in the revamped Hockey India League, as the mentor of its

women's team. The player from Shahabad, considered a cradle of Indian hockey, rose from abject poverty to

make the national team. Her father Ram Pal, who has been her guiding force, earned a mere Rs 80 per day and could not afford to even buy her a hockey stick. She was rejected by a district-level coach for being malnourished as a child but continued to practice with a broken hockey stick that she stumbled upon in a field.

Despite the many obstacles, including initial opposition from her conservative family, Rani made the local team as a six-year-old before becoming the youngest hockey player to turn up for India as a 14-year-old.
