दिल्ली सरकार ने गैर-घरेलू बिजली उपभोक्ताओं को दी राहत, फिक्स्ड चार्ज किया आधा

महालक्ष्मी व्यूरो
नई दिल्ली, 08 सितम्बर
दिल्ली विद्युत नियामक आयोग (डीईआरसी) ने गैर-घरेलू, वाणिज्यिक और औद्योगिक उपभोक्ताओं की समस्याओं और उद्योग संघों की मांग को देखते हुए, अगले और मई में पूर्ण लॉकडाउन अवधि के दौरान तक बिजली के फिक्स्ड चार्ज को 50 प्रतिशत तक घटा दिए हैं। इस अवधि के दौरान इन उपभोक्ताओं को 250 रुपये प्रति किलोवाट घंटा की दर पर बिजली की आपूर्ति की जाएगी।

डीईआरसी की ओर से जारी आदेश को दृष्टिगत करते हुए मुख्यमंत्री अरविंद केजरीवाल ने कहा कि दिल्ली सरकार संकट की इस घड़ी में दिल्ली के लोगों के साथ खड़ी है। फिक्स्ड चार्ज में राहत देने से कोरोना के कारण कठिनाइयों का सामना कर रहे लाखों लोगों को मदद मिलेगी। डीईआरसी की ओर से जारी आदेश में कहा गया है, कोविड-19 के प्रकोप के कारण प्रचलित गंभीर स्थिति पर विचार कर रहे आयोग ने डीईआरसी टैरिफ विनियम 2017 के विनियम 168 और 172 के तहत अपरिचित व्यक्तियों का प्रयोग किया था और डीईआरसी (अपूर्ति संहिता और प्रदर्शन मानक) विनियम 2017 के विनियम 84 और 85 दिल्ली के बिजली उपभोक्ताओं सहित हितधारकों को पेश आ रही कठिनाइयों को दूर करने के लिए किया था।

दिल्ली की 109 साल पुरानी दुर्गा पूजा की परंपरा इस साल टूट जाएगी

नई दिल्ली, 08 सितम्बर
अगले महीने होने वाली दुर्गा पूजा के आयोजन पर भी कोरोना का साथ बंधा रहा है। दिल्ली की 109 साल पुरानी दुर्गा पूजा भी कोरोना के असर से अक्षुण्ण नहीं रही। दिल्ली में हर साल दुर्गा पूजा पर भूमिदास से जगह-जगह भव्य पैडाल सजते हैं, लेकिन कोरोना के चलते इस बार दिल्ली की ऐसी स्थिति देखने को नहीं मिलेगी। कुछ समितियों ने पूजा आयोजित न करने का निर्णय लिया है तो कुछ ने सड़क के साथ बंद छोटे स्तर पर पूजा का फैसला किया है, हालांकि पूजा पैडाल नहीं लगाया जाएगा।



समिति के कोषाध्यक्ष अरुण घोषाल ने बताया कि इस बार चंद्र इकठ्ठा करना भी चुनौतीपूर्ण कार्य है। कलाकारों ने अपने से इंकार किया दुर्गा पूजा पर पैडाल सजाने और मां दुर्गा के स्वरूप की मूर्ति बनाने, पूजा अर्चना के लिए पुजारी सहित दूसरे कार्यों के लिए कोलकाता से

पहली बार होगा कि बंद सादरी के साथ दुर्गा पूजा का आयोजन होगा। पिछले 109 सालों से पूजा समारोह के बाद मां दुर्गा की प्रतिमा को विसर्जन के लिए कैलाशगढ़ी पर ले जाने की परंपरा भी टूट जाएगी। बिना बड़ी मूर्ति के बंद छोटी पूजा होगी, जिसमें केवल समिति के सदस्य ही हिस्सा ले सकेंगे। कोई सांस्कृतिक कार्यक्रम और किसी तरह का कोई त्योहार नहीं रहेगा।

चित्रांगन पार्क में कॉर्पोरेटिव ग्रांटेड दुर्गा पूजा समिति के कार्यकारी सदस्य राहुल चक्रवर्ती ने बताया कि इस बार कोरोना के चलते पूजा का आयोजन न करने का फैसला लिया गया है। सिर्फ एक दिन नवमी वाली दिन छोटे स्तर पर पूजा की जाएगी। कोरोना वाइरस के बीच दुर्गा पूजा समिति के चेयरमैन विभाष चंद्र मंत्री का कहना था कि इस बार पूजा पैडाल नहीं लगाएंगे। इस बार शुनूची नृत्य और सिंदूर खेल भी नहीं होगा। कोरोना के बढ़ते मामलों के मद्देनजर यह निर्णय सही है, जिससे लोग सुरक्षित रहें। सरकार ने भगवान गणेश की पूजा के लिए भी पैडाल लगाने की अनुमति नहीं दी थी, ऐसे में दुर्गा पूजा के पैडाल को लेकर उम्मीद बंद कर दी।

भाजपा पार्षदों ने सिविक सेंटर से दिल्ली सचिवालय तक पदयात्रा कर किया विरोध प्रदर्शन

नई दिल्ली, 08 सितम्बर
दिल्ली सरकार द्वारा नगर निगम के फंड को रोकने के विरोध में आज तीनों निगमों के बरिष्ठ पदाधिकारियों एवं भाजपा पार्षदों ने निगमों का फंड रिबीज न करने को लेकर सिविक सेंटर से दिल्ली सचिवालय तक पदयात्रा कर विरोध प्रदर्शन किया, लेकिन बीच में उनको रोक लिया गया और राजेश्वर नगर थाने ले जाये के उपरांत छोड़ दिया गया। इसका नेतृत्व दिल्ली भाजपा अध्यक्ष श्री आदेश गुप्ता ने किया। इस पदयात्रा में संधिया नगर निगम महापौर श्रीमती अनामिका मिशेलो, उप महापौर श्री सुभाष भट्टाना, स्वाई

समिति अध्यक्ष श्री राजदत्त गहलोत, उपाध्यक्ष श्रीमती तुलसी जोशी, नेता सदन श्री नरेंद्र चावला, नेता सदन प्रवेश शर्मा, पूर्वी दिल्ली नगर निगम महापौर श्री निरमल जैन, उप महापौर श्री हरि प्रकाश बहादुर, स्वाई समिति अध्यक्ष श्री स्वप्नलाल सिंह, उपाध्यक्ष श्री शैलेंद्र मल्होत्रा, उत्तरी दिल्ली नगर निगम उप महापौर श्रीमती रिशु गोयल, स्वाई समिति अध्यक्ष श्री डेल विहारी

मेन्सवर्मी, उपाध्यक्ष श्री विजेंद्र यादव, नेता सदन श्री योगेश वर्मा, सहित तीनों निगमों के पार्षदों ने हिस्सा लिया। श्री गुप्ता ने कहा कि यह बहुत ही दुःख है कि कोरोना संकट में निगम के सफाई कर्मों एवं अन्य कर्मचारी अपनी जान जोखिम में डालकर, कंटेनमेंट जोन तक में जाकर काम कर रहे हैं और फिर उन्हें वेतन के लिए भी अडोलन करना पड़ रहा है। दिल्ली की सत्ताधारी आम आदमी पार्टी के नेता दिल्ली की बंदा शहर बता कर सफाई कर्मियों की मेहनत का भी अमान्य कर रहे हैं। निगमों के स्वास्थ्य कर्मों को या सिविक सचि की मार्ग से अब तक

कोरोना काल में रात दिन काम कर लाखों मर्तों कड़ेवाँ लोगों तक भोजन एवं दवाई आदि पहुंचाने का काम किया है, पर आज वह धरना और आंदोलन करने को बेवस है। उन्होंने कहा कि कोरोना काल में निगमों के अपने श्रेतों से राजस्व बिलकुल नहीं आ रहा है क्योंकि लोग सम्पत्ति कर, कनवरजन चार्ज एवं विभिन्न अन्य नियम कर जमा करने की स्थिति में नहीं हैं। अब निगमों की आर्थिक स्थिति सम्पूर्ण रूप से सहयोग देने की जगह दिल्ली सरकार के मंत्री एवं आम आदमी पार्टी नेता दिल्ली नगर निगमों के प्रशासक दल भाजपा एवं निगम

अधिकारियों पर भ्रष्टाचार के आरोप लगाकर भ्रम की स्थिति बनाने की ओर राजनीति कर रहे हैं। श्री गुप्ता ने कहा कि दिल्ली सरकार के वजेट अनुसार इस वर्ष 2020-21 में पूर्वी दिल्ली निगम को फंड 1677 करोड़ रुपये हैं, पर आज 7 सितम्बर तक उसमें से केवल 157 करोड़ रुपये मिले हैं।

अमानतुल्लाह के नामांकन को चुनौती देने वाले याचिकाकर्ता को झटका

नई दिल्ली, 08 सितम्बर (ह.स.)
राजधानी दिल्ली में खतारुद्द आम आदमी पार्टी (आप) के विधायक अमानतुल्लाह खान के दिल्ली वक्फ बोर्ड का सदस्य चुने जाने के लिए पश्तल नामांकन को चुनौती देने वाले याचिकाकर्ता पर लगाए गए 25 हजार रुपये के जुर्माने को माफ करने से दिल्ली हाईकोर्ट ने मंजूरवार को इनकार कर दिया है। हाईकोर्ट ने कहा कि याचिकाकर्ता ने अपनी याचिका में कहा था कि अगर जुर्माना लगाया जाता है तो यह इसका भुक्तान करना और उसके पास पैसा करने का साधन था, लेकिन अब वह आर्थिक तंगी का बचाव कर रहा है। चोफ जस्टिस डी.एन. पटेल और जस्टिस प्रतीक जलान की बेंच ने याचिकाकर्ता मोहम्मद तुफैल खान से कहा कि आपसे किसने याचिका दायर करने को कहा था। इसके साथ ही कोर्ट ने जुर्माना माफ करने के लिए किफाई आदेश को खारिज कर दिया। अदालत ने याचिकाकर्ता के वकील द्वारा जुर्माने की राशि को माफ करने के अनुरोध पर सुनवाई करने से भी इनकार कर दिया। उल्लेखनीय है कि खुद को सामाजिक कार्यकर्ता बताते वाले तुफैल खान ने दायर किया था कि दिल्ली वक्फ बोर्ड के सदस्य के लिए दिल्ली सरकार द्वारा 'आप' विधायक का चुनाव के लिए नामांकन कराना बैर कानूनी, मन्माना और भेदभावपूर्ण है।

दिल्ली हाईकोर्ट ने कहा- यदि सरकार दिव्यांगों को कम कीमत पर अनाज नहीं देगी तो हम आदेश देंगे

नई दिल्ली, 08 सितम्बर (ह.स.)
दिल्ली हाईकोर्ट ने कहा कि खाद्य सुरक्षा कानून के तहत कम कीमत पर अनाज पाने वालों को श्रेणी में यदि कोई, केंद्रीय और घरेलू सप्लाई को रखा जा सकता है तो इस श्रेणी में दिव्यांगों को क्यों नहीं रखा जा सकता। चीफ जस्टिस डी.एन. पटेल और जस्टिस प्रतीक जलान की बेंच ने सरकार को केंद्र सरकार से पूछा कि दिव्यांग श्रेणी को क्यों नहीं शामिल किया गया? जब आप मोची, कैरीवाली और घरेलू सप्लाई को शामिल कर रहे हैं तो दिव्यांगों को क्यों नहीं शामिल करने के लिए संसद द्वारा अलग से एक कानून बनाया गया है। यह केवल उनकी सहायता के लिए है। आप एक श्रेणी को छोड़ देंगे तो इस श्रेणी को क्यों भूल गए। बेंच ने कहा कि यदि सरकार यह नहीं कर सकती तो हम आदेश देंगे। केंद्र सरकार द्वारा हलफनामे का जवाब देकर गंगा या जिनमें राष्ट्रीय खाद्य सुरक्षा कानून और संबंधित योजनाओं के तहत कम कीमत पर अनाज पाने वाले लोगों की श्रेणी उल्लिखित थी। सरकार के जवाब का संज्ञान लेते हुए अदालत ने यह टिप्पणी की। एक गैर सरकारी संगठन की ओर से दायर अनर्हित याचिका के जवाब में हलफनामा दायर किया गया था। अनर्हित याचिका में केंद्र और राज्य सरकारों से मांग की गई थी कि कोविड-19 महामारी के इस दौर में विभिन्न खाद्य सुरक्षा तथा गरीबी उन्मूलन योजनाओं का लाभ दिव्यांगों को भी दिया जाए। चौडिये कॉन्ग्रेस के जयिरे हुई सुनवाई के दौरान बेंच ने कहा कि प्रत्येक समाज या समुदाय में महिलाओं, बच्चों, वृद्ध नागरिकों, दिव्यांगों, कैरीवाली और मानसिक रूप से अक्षय व्यक्ति को प्राथमिकता दी जाती है। बेंच ने सरकार से कहा कि एक संकुल के द्वारा सट किया जाए कि राष्ट्रीय खाद्य सुरक्षा कानून और अन्य योजनाओं के तहत कम कीमत पर अनाज पाने वाले लोगों की श्रेणी में दिव्यांग भी हैं। अदालत द्वारा उद्घार कर विधुओं का जवाब देने के लिए अतिरिक्त महामहिता चेतन शर्मा ने और समय मांगा।

दिल्ली में कोरोना जांच के लिए डॉक्टर का पर्चा दिखाना जरूरी नहीं: हाईकोर्ट

नई दिल्ली, 08 सितम्बर (ह.स.)
दिल्ली हाईकोर्ट ने मंगलवार को आदेश दिया कि राजधानी दिल्ली में कोरोना वायरस संक्रमण का परीक्षण करने के लिए डॉक्टर / पीसीआर टेस्ट के लिए स्वेच्छ से जाने वालों के लिए अब से डॉक्टर का पर्चा अनिवार्य नहीं होगा। अब तक किसी व्यक्ति द्वारा कोरोना जांच करने के लिए डॉक्टर का पर्चा या बीमारी के लक्षण होना जरूरी था। जस्टिस हेमा कोहली और सुभ्रमण्यम प्रसाद की बेंच ने कहा कि कोविड-19 जांच कराने के इच्छुक लोगों को दिल्ली में निवास प्रमाणपत्र के तौर पर अपना आधार कार्ड ले जाना होगा और भारतीय चिकित्सा अनुसंधान परिषद द्वारा निर्धारित फॉर्म भरना होगा। हाईकोर्ट ने कहा कि दिल्ली में कोरोना वायरस के मामलों की संख्या में तेजी से वृद्धि हुई है ऐसे में जो भी लक्षण स्वेच्छ से अपनी कोरोना जांच कराना चाहते हैं उनके लिए निजी प्रयोगशालाओं को प्रविष्टि 2,000 टेस्ट की अनुमति देने के लिए कहा गया है।

Govt, civic body begins removing concrete around trees in Old Delhi

New Delhi/September 08
 A tall peepal tree, believed to be more than 100 years old, stands within a house behind Jagat Cinema near Jama Masjid in the Walled City. One of its branches has been cut and a portion of its trunk has been concretised to accommodate the construction around it. It is one of the 24 old and full-grown trees in the densely populated Old Delhi, which are being restored by the North Delhi Municipal Corporation and the Delhi government's forest department on directions of the Delhi High Court.

While some of these trees have permanent or semi-permanent structures around their trunks, damaging their roots, others have been heavily pruned over the years.

A team of officials from the corporation and the forest department had conducted a joint survey of the area last month and started removing the concrete around them.

Sixty-seven-year-old Omwati, the oldest resident of the three-storey house which has come up around the peepal, said the tree has been a saviour for the three generations that have lived there. "We believe that it has protected us from all evil. In 1970, a huge branch that was spreading up to the next building was cut by its owner, as it was coming in between the construction he was doing. Its branches would provide shade to the entire house and had to be pruned several times over the years for sunlight to pass through," said Omwati.

Omwati said she was 13 when she came to the house after her marriage and the tree had been there ever since. "A few days ago some officials had come to inspect the tree and said that they would put a number on it in order to save it from further damage," she said.

According to a senior forest official, who did not wish to be named, said, "In case of this tree, de-concretisation cannot be done, as it is too close to the foundation of the old house and also there is lack of space, which may pose a danger to the building."

Deputy conservator of forests (DCF-North) Aditya Madanpota said a number of trees that had grown inside the house or a wall, de-concretisation could not be carried out because of



limited space and potential danger to the building. "In rest of the trees where religious structures have come up around tree trunks, the matter has been referred to the Delhi government's religious committee for action as per norms. Besides, around other trees, the cemented boundaries have been broken allowing them space to breathe and water to seep into their roots," he said.

He added that since most of these 24 trees are peepal or neem, which regenerate fast, the root system has been preserved. "We will keep monitoring them and in case any further encroachment is reported, we will put up tree guards around them," said Madanpota.

As per an affidavit filed by the North Corporation in the Delhi High Court on September 2, at least eight of the 24 trees have religious structures around their

trunks in Chandai Chowk municipal ward. Also, the tree branches are wrapped in a web of wires and cables in most places.

The corporation submitted the affidavit listing the old trees in Dariba Kalan, Urdu Bazar, Jama Masjid, Jagat Cinema area and Kinari Bazar, among others on the court's directions which came during a hearing in a plea to restore an approximately 300-year-old banyan tree in Nai Sadak area of Chandni Chowk. On August 6, Nai Sadak resident Nitin Gupta had filed a plea about unauthorised construction that was damaging the tree.

At Kinari Bazar's, Gali Peepal Wali, locals said the old peepal tree there. "The tree has been here for at least the three generations that I have seen. A team of officials had visited the site some days ago and broke down some structures that had come up around the tree," said Hazari Lal, 73, who owns a decorative items shop nearby.

At Cycle Market near Dariba Kalan, another peepal tree, almost five-storey tall, had cement around its trunk as a temple had come up on it. "I have been seeing this tree since at least 1983 when I started working here. The religious structure had been there since," said Bajeev Khurana, who owns a shop in the compound. At least five trees on the Netaji Subhash Marg and Urdu Bazar Road fall under the jurisdiction of the Public Works Department (PWD) and de-concretisation has been carried out here.

AAP protests for pending salaries of MCD workers

 Councillors of Aam Aadmi Party (AAP), led by senior leader Durgesh Pathak, on Monday joined employees of the three municipal corporations (MCDs) outside Civic Centre building to protest against non-payment of pending salaries.

Pathak, who is AAP's MCD in-charge, along with a bunch of other party members and councillors, was later detained by Delhi Police.

"We demand that the Bharatiya Janata Party (BJP) release the salaries of MCD workers within the next week. If you (the BJP) cannot run the MCD, then please resign and hand it over to the AAP. The Arvind Kejriwal-led party will run it better in the same



budget. It has been about six months that the employees of the corporation have not got their salaries," Pathak said.

He further said that the AAP will continue to protest until the BJP-ruled MCDs settle the salaries of all its employees.

The BJP, however, denied AAP's allegations and said the Kejriwal led

party was making baseless claims to garner support from the people of Delhi ahead of municipal elections. MCD elections are scheduled some time in April, 2023. The BJP had managed to win a majority in all the three civic bodies during the last polls held in April 2017.

Delhi BJP chief Adesh Gupta said the AAP government had not given MCD its dues till now. "As per the Delhi municipal corporation act, 2013, the Delhi government is bound to release annual municipal funds by June 30 every year. But till date, the AAP government has not even released 28% of the allocated funds for 2020-21," he said.

AAP chief spokesperson and Greater Kailash MLA

Saurabh Bhardwaj on Monday said the Uttar Pradesh government detained AAP Raya Sabha MP Sanjay Singh on Sunday, when he went to meet the family of former UP MLA Nirvendra Mishra, who died after allegedly being beaten up in the presence of police officers.

"The Yogi Adityanath government has registered 13 different FIRs against Sanjay Singh to terrorise him and yesterday (Sunday) they detained him.

This is just to terrorise him and to stop his voice, because he is talking about the rights of Dalits and Brahmins in UP," Bhardwaj said.

Install tree guards to protect saplings from monkeys: Delhi HC to NDMC

 The Delhi High Court has directed the New Delhi Municipal Council (NDMC) to protect 500 newly planted amaltas saplings in parts of the Central Ridge area from monkeys by installing tree guards. The direction came after the court was informed that monkeys not only damaged the tender branches but sometimes uprooted the saplings.

The NDMC counsel submitted photographs to Justice Najmi Waziri -- who was hearing a bunch of pleas on tree plantation -- showing that 500 amaltas saplings had been planted in various parts of the Central Ridge. The counsel told the court that the saplings have been interspersed with trees of other varieties, ensuring that there is no mono-culture. However, she said monkey menace was a threat. "To safeguard these young vulnerable trees, it will be worthwhile for the council to install appropriate tree guards wherever deemed necessary, so as to prevent tree-attribution due to monkey menace. Affidavit of compliance be filed before the next date," the court said. Noting that more than 100,000 trees had been planted all over Delhi in the last two years under its directions, Justice Waziri said many of these were contributed by litigants in hundreds of cases as costs or fine. He said the endeavour to create and augment the green cover with indigenous deciduous trees, both in the heart of the city and on its periphery, is a collective exercise for the enrichment of Delhi's ecology.

To pay for PUBG, boy transfers ₹2.3L from grandad's pension account

 A 15-year-old boy in North Delhi's Timarpur transferred money from the pension account of his grandfather to an online wallet to fund his PUBG game for months, Delhi Police said on Monday after cracking the case.

Over a period of two months, the boy transferred Rs2.34 lakh from his 65-year-old grandfather's account until the man was alerted of the transfers, Anto Alphonse, deputy commissioner of police (Dwarka), said.

While the boy managed to scale ace levels, largely due to his ability to pay, he couldn't take full advantage of the game. "He told us his PUBG account was hacked after he reached a particular level," the DCP said.

No legal action is likely to be pursued against the boy since his grandfather has



decided to let go of the matter on getting to know who was withdrawing his money, said another investigator.

On May 8, he received a message on his phone, informing him of withdrawal of Rs2,500 from his bank account, leaving him with just Rs 275 in his account. "He visited the bank to realise that a total of Rs2.34 lakh had been transferred from his account to a PayTM account

in multiple installments in over two months. He then approached us," the DCP said.

The police didn't make much progress in the probe over the next few months, but on September 1, the case was transferred to the cyber branch of north Delhi police district.

"We contacted PayTM to identify the man into whose account the money was being transferred. The account holder told us his minor friend had requested him to lend him his PayTM ID and password. Soon, we got to know that the boy was the complainant's grandson," the DCP said.

When the police spoke to the boy, he allegedly said he had been playing the game for months, but wasn't enjoying it since it needed payments for certain advantages.

"One day, he found his grandfather's debit card.
